



ENVIRONMENTAL SERVICES

In the vast field of environmental services, we deal with it across the board, and in particular with the following activities:

- Remediation of friable and compact asbestos and man-made vitreous fibres
- Emergency safety measures for sites at high environmental risk
- Remediation of contaminated sites
- Remediation in confined or explosion-risk spaces
- Treatment of solid and liquid waste using authorised mobile plants (filter presses, centrifuges, evaporators, screens, shredders and inertisation plants)
- Network and facilities maintenance
- Geotechnical and environmental investigations and characterisation for contaminated sites
- Environmental analyses of soil, subsoil, surface and groundwater and waste characterisation in solid and liquid matrixes



MARINE SERVICES




SIR is able to provide a wide range of services in the marine and port sectors.

More specifically, the company provides a service for the collection and transport of ship-generated waste and cargo residues. SIR also employs its own naval and land vehicles in the ports of Brindisi and Taranto.


While still in the marine field, the company owns a ten-year concession for the operation of the marine bunkering service (the supply of fuels to ships berthed and approaching the port of Taranto) operating with the Eni Refinery in Taranto and with the most important traders of national oil products.








PORT COMPANY



At the industrial ports of Brindisi, Taranto, Portoscuso and Oristano we take care of the embarkation/disembarkation from ships and the related port operations of the following goods:

- bulk such as coal, fertiliser, ore, sand, ash, etc.
- hazardous and non-hazardous waste
- project cargo and exceptional plant
- containers and rolling stocks


With our wide range of equipment and highly qualified staff, we are able to undertake loading and unloading operations for goods of any kind, volume and size. All port operations are carried out in strict compliance with safety regulations for the maximum protection of both personnel and the goods handled. In addition, we also take care of cargo weighing, hold cleaning, and container remediation and repair.







DECOMMISSIONING



We deal with decommissioning industrial plants, infrastructure and urban buildings.

For this highly specialised activity, we make use of best practices for minimising dust and reducing waste generated by the work performed.

We use advanced equipment, which allows us to operate in environments that are particularly complex for human activities (e.g. work in confined spaces).

- Demolition and reclamation of disused industrial facilities
- Controlled demolition of reinforced concrete structures
- Demolition and tank reclamation
- Dismantling of industrial plants in operation







TRANSPORT OF GOODS AND WASTE



Thanks to a large fleet of machines, we are able to respond to the land transport needs of many different types of goods and waste, whether in a solid, liquid, slushy or powdery state.

- Intermodal and cross-border transport of all kinds of goods
- Transport of municipal waste, hazardous and non-hazardous, in solid, liquid and powdery matrix
- Hire of watertight swap bodies and their transport
- Container and swap body transport
- Warehousing and logistics of goods for third parties
- Transport of liquid foodstuffs
- Maritime transport of small quantities of goods and waste

In addition, our vehicles are equipped with GPS for prompt tracking of routes, an on-board weighing system to travel at maximum capacity and optimise time for the benefit of customers and suppliers, an ecological emergency response contract in the event of a road accident, and insurance policies for goods (damage, theft, loss, leakage, environmental pollution).



WASTE MANAGEMENT PLANTS



At its production site in Brindisi, SIR has a plant for the recovery of non-hazardous waste approved by Single Environmental Authorisation nr. 131 of 10/12/2014 issued by the Province of Brindisi Ecology and Environment Service.

Furthermore, the company also has an additional plant for the treatment and disposal of special non-hazardous waste, approved under Authorisation Measure nr. 2 of 15/01/2018 of the Ecology and Environment Service of the Province of Brindisi. An ambitious project to expand and upgrade the current facilities is also underway.

And besides, SIR has a number of authorised mobile waste treatment plants, such as centrifuges, shredders, screens and presses.



Wheel and track loaders, dozers and track excavators, backhoe loaders and skid loaders


